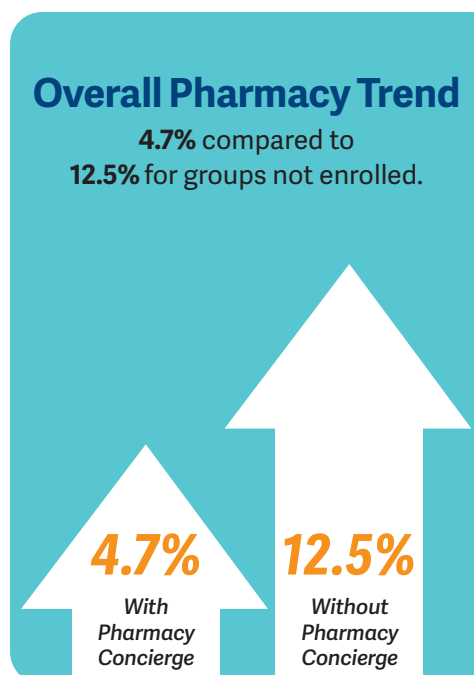

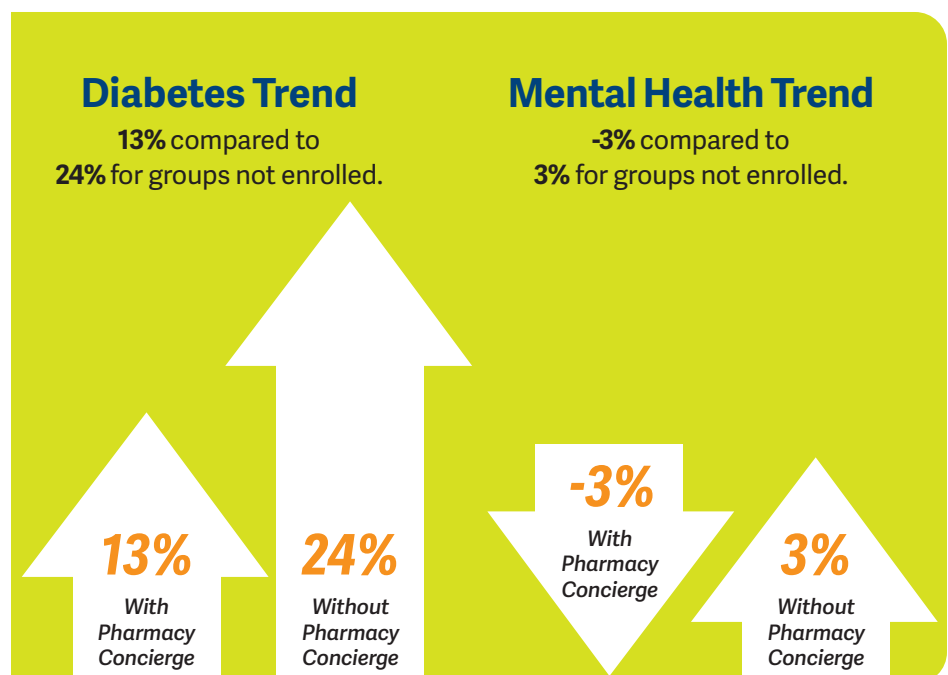
2021/2022 Proven Savings: Mitigating Rx Trend
